## **NOTES:**

**Level 1** students are not listed because they are not eligible to apply for a District Minister's License until AFTER they have completed the equivalent of a year of the ministerial course of study.

## Students are placed in ...

- **Level 2** when they have completed the equivalent of ¼ of the course of study, or a minimum of 6 courses.
- **Level 3** when they have completed the equivalent of ½ of the course of study, or a minimum of 12 courses
- **Level 4** when they have completed the equivalent of ¾ of the course of study, or a minimum of 18 courses.
- **Graduated** when they have completed 100% of an approved course of study. In the Modular COS program that is 25 courses.
